



Tryout Information 2010-11

Welcome to Southpointe Hockey tryouts. The following document and registration form explains in detail the tryout process for SAHA. Please read it carefully. Pre-registration is preferred, but walk-ins are also welcome. All tryouts will be at the Iceplex at Southpointe, Canonsburg PA 15317

Tryouts will begin on Monday, April 19 and will be completed by Saturday, May 1 and will be held at scheduled times listed in the chart below for each age **and** skill level division, with Team 1 being the top rated team, followed by Teams 2,3, and 4 in that order. Note that all age levels may or may not have up to 4 teams. **GOALIES at all levels will be offered FREE tryouts once again this season and are required to attend the appropriate tryout for their age group.** Tryouts for the Girls teams (U14 and U19) will be held separately from the boys, although girls are able to tryout for both a boys and girls team, in accordance to PAHL rules, also for one registration fee. Also this year, we will be fielding a birth year 1997 bantam team that will participate in numerous tournaments and PAHL. More specific information regarding this team is available from our Director of Coaching, Mike Singleton. (See Bantam team declaration form for specific information)

Registration / Pre-registration Information

Please complete, sign and mail the attached registration form, along with the pre-registration payment of \$125, by April 1, 2010 to **SAHA, PO Box 887, McMurray PA 15317**. Walk-ins, or players not pre-registered by April 1, will be required to pay a \$150 registration fee before they can participate in the tryout process. Registration fees are non-refundable, whether or not the player attends tryouts or declines the position offered.

All players and goaltenders must bring a \$300 commitment fee check, made payable to **SAHA**, to the first day of tryouts. This amount will be applied to the 2010-11 assessment fees. No players will be permitted to participate in the tryout process until the registration and commitment fees have been paid.

Please note all deadlines for player placements and commitment fees are strictly adhered to and are specifically detailed on the following page. Exceptions are not permitted. Please contact us at www.southpointehockey.org with questions regarding the schedule and policies.

Guidelines for Team Placements, Postings and Commitment Deadlines

Team 1 Tryouts (except for Midgets and Girls)

- ***For players placed on Team 1:***

Following the Team 1 tryouts, players placed on these teams will be contacted by phone from the head coach regarding their position. Players accepting the offered Team 1 position will need to communicate this decision directly with their head coach. Players choosing **not** to accept the Team 1 position offered will have until the specified commitment deadlines (listed on chart above) to respond, **via email** to hockeyinfo@southpointehockey.org, to decline their placement on the team and to have the \$300 commitment fee refunded. ***After the commitment deadline, the commitment fee will be non-refundable,** and SAHA will reserve the right to withdraw the Team 1 position offer to the player. (See Bantam team declaration form for specific information regarding the Bantam team 1 and 97 birth year team tryout process).

- ***For players not placed on Team 1:***

Players who attended the Team 1 tryout but are **not** placed on the team will be notified by email and will automatically be registered to return to the second tryouts (Teams 2-4). Players choosing to withdraw from the SAHA tryout process and not attend the second tryout will have their commitment fee returned **only** if notification is made through email prior to the start of the second tryout. ***Players failing to show for the second tryout without notification of withdrawal will not be eligible for the refund of the commitment fee.**

Teams 2-4 Tryouts (plus all midgets and girls):

Following this tryout, players will be notified by a SAHA representative, either the head coach or board member, and offered a position on a team. Team placement postings will also be listed by pinney number on our website. Each player will have until the specified deadline, listed in chart above, to decline the position offered by email. If declining, the \$300 commitment fee will be refunded and SAHA will reserve the right to withdraw the position offered. ***After the Commitment Deadline, the commitment fee will be non-refundable.**

Statement of Representation and Consent for Participation, Physical Condition, Medical Attention, Indemnification, and Insurance
**** Parent or Guardian must read carefully, complete and sign****

I, the undersigned parent/guardian of the above-named minor child ("player") by signing this statement, and in consideration of the acceptance of player as a participant in the ice hockey program sponsored and operated by the Southpointe Amateur Hockey Association, Inc. ("SAHA") a non-profit organization and a member of the Pittsburgh Amateur Hockey League ("PAHL"), hereby agree and represent myself on behalf of player as follows:

I consent to, and player is authorized to, participate in all aspects of the program. Player has no pre-existing or known physical or mental incapacity or condition that would increase the normal risk of injury to player or others participating in the program.

In the event player becomes ill or is injured while participating in the program or any activity related thereto, including travel to and from such activities, and no parent or guardian is present, I consent to a SAHA Officer, Director, Coach, Business Manager and/or any other person authorized by SAHA to seek and/or obtain medical care for the player from a licensed physician, dentist, hospital, medical clinic, infirmary, or similar establishment including any surgical treatment if the same be determined necessary.

I hereby agree to assume all risks and hazards incidental to player's participation in the program including those involved in traveling to and from all such activities and I, both individually and on behalf of the player, do hereby release, absolve, indemnify and hold harmless SAHA, its officers, Directors, members, coaches, managers, referees, supervisors, players and any other person authorized by SAHA to act in connection with the program, for any damages arising out of any injuries to player. I acknowledge that I have read and agree to be bound by the USA Hockey waiver of liability, release, assumption of risk, and indemnity agreement.

At the end of the playing season or at the request of the SAHA Board or its representative I will return all SAHA owned property, which was issued to the player. I will be responsible for any property damage caused by the player.

To the extent that any injury sustained by player is covered by insurance provided by or for the undersigned, I understand that such insurance shall be considered primary to the full extent of any such insurance coverage. SAHA shall have no responsibility to provide any insurance coverage and in the event that it does obtain insurance coverage, it shall be subordinate and secondary to the full amount of any and all insurance provided by for the undersigned.

I and my son/daughter (player) agree to abide by all protective equipment rules as set forth by USA Hockey, the PAHL and SAHA.

I understand that SAHA reserves the right to limit player participation based on the number of teams entered into competition, as well as qualified coaches to instruct hockey. Additionally, I understand that SAHA and PAHL are competitive hockey programs and the PAHL makes the final determination in the level of play for every team.

I agree to pay all fees as outlined in the attached 2010-11 Assessment Fee Schedule and acknowledge that all fees are NON-REFUNDABLE. In the event that a player/goaltender sustains a season-ending on-ice injury, medical condition or illness, prior to November 30, 2010, SAHA, at their sole discretion, may offer a partial credit of the paid 2010-11 Assessment Fees. On-ice injuries are limited to SAHA team related practices, scrimmages, tournaments and PAHL games, only, and must be documented at the time of occurrence, and presented in writing, within 14 days, to Southpointe Amateur Hockey Association Board of Directors, c/o P.O. Box 887, McMurray PA 15317. **Voluntary withdrawal by a player/goaltender from SAHA, for any reason, will result in the forfeiture of all fees paid on behalf of the player/goaltender and all outstanding balances must be paid in full.**

2010-11 Notes:

The \$300 commitment fee is due on the day of tryouts for every player and goaltender. This fee is applied toward the 2010-11 assessment fees. No player or goaltender shall be permitted to participate in tryouts without paying the applicable registration and commitment fees.

After team placement, players have until the posted commitment deadline to decline the position offered (Refer to the schedule on the previous page for specific dates).

If a player declines the position offered by the deadline, the commitment fee will be returned and Southpointe Hockey reserves the right to withdraw the position offered.

Any declines received after the deadline will NOT be eligible for the commitment fee refund — NO EXCEPTIONS.

Discounted Assessment Fees for Goaltenders and Mites are payable under the Installment Plan only. No further discounts will apply.

As per our contract with Iceoplex, SAHA will provide email addresses of its players to Iceoplex for marketing purposes. Should you not want your email address shared with Iceoplex, please notify us in writing via our website at hockeyinfo@southpointehockey.org.

Players will be required to register with USA Hockey and pay the required fees, by 6/01/10 to USA Hockey to be rostered on a SAHA team.
